1 TERMS OF ACCEPTABLE USE AND INFORMATION ABOUT US

- 1.1 This acceptable use policy sets out the terms between you and us under which you may access our website http://www.composide.com ("our site"). This acceptable use policy applies to all users of, and visitors to, our site.
- 1.2 Your use of our site means that you accept, and agree to abide by, all the policies in this acceptable policy, which supplement our terms of website http://www.composide.com/wpcontent/uploads/2014/11/CompoSIDE Terms of Use November 2014
- 1.3 http://www.composide.com is a site operated by Composide Limited ("We" or "us"). We are registered in England and Wales under company number 08733662 and have our registered office at New Kings Court, Tollgate, Chandlers Ford, Eastleigh, Hampshire, SO53 3LG United Kingdom. Our main trading address is Old Riggers Loft, Marina Walk, Cowes, Isle of Wight, PO31 7XJ, United Kingdom. Our VAT number is GB 178 7940 48.

2 **PROHIBITED USES**

- 2.1 You may use our site only for lawful purposes. You may not use our site:
 - 2.1.1 In any way that breaches any applicable local, national or international law or regulation.
 - 2.1.2 In any way that is unlawful or fraudulent, or has any unlawful or fraudulent purpose
 - 2.1.3 For the purpose of harming or attempting to harm minors in any way.
 - 2.1.4 To send, knowingly receive, upload, download, use or re-use any material which does not comply with our content standards, as set out in Clause 4 below.
 - 2.1.5 To transmit, or procure the sending of, any unsolicited or unauthorised advertising or promotional material or any other form of similar solicitation ("spam").
 - 2.1.6 To knowingly transmit any data, send or upload any material that contains viruses, Trojan horses, worms, time-bombs, keystroke loggers, spyware, adware or any other harmful programs or similar computer code designed to adversely affect the operation of any computer software or hardware.
 - 2.1.7 To knowingly use, or attempt to use, any software application, or any similar or comparable device or application, that runs automated tasks over the internet to use, access or harvest data from our site, other than any designated API functionality or other software that we supply to you for that purpose.
- 2.2 You also agree:



- 2.2.1 Not to reproduce, duplicate, copy or re-sell any part of our site in contravention of the provisions of our terms of website use http://www.composide.com/wpcontent/uploads/2014/11/CompoSIDE Terms of Use November 2014.pdf
- 2.2.2 Not to access without authority, interfere with, damage or disrupt:
- 2.2.3 any part of our site;
- 2.2.4 any equipment or network on which our site is stored;
- 2.2.5 any software used in the provision of our site; or
- 2.2.6 any equipment or network or software owned or used by any third party.

3 INTERACTIVE SERVICES

- 3.1 We may from time to time provide interactive services on our site, including, without limitation:
 - 3.1.1 Chat rooms;

 - 3.1.3 Forums; and
 - 3.1.4 YouTube channels.

(together the "interactive services" and each an "interactive service").

3.2 Where we do provide any interactive service, we will provide clear information to you about the kind of service offered (including whether it is human or technical).

4 **CONTENT STANDARDS**

- 4.1 These content standards apply to any and all material which you contribute to our site ("content standards"), and to any interactive services associated with it.
- 4.2 You must comply with the spirit and the letter of the following standards. The standards apply to each part of any contribution as well as to its whole.
- 4.3 Contributions must:
 - 4.3.1 Be accurate (where they state facts).
 - 4.3.2 Be genuinely held (where they state opinions).
 - 4.3.3 Comply with applicable law in the UK and in any country from which they are posted.
- 4.4 Contributions must not:



- 4.4.1 Contain any material which is defamatory of any person.
- 4.4.2 Contain any material which is obscene, offensive, hateful or inflammatory.
- 4.4.3 Promote sexually explicit material.
- 4.4.4 Promote violence.
- 4.4.5 Promote discrimination based on race, sex, religion, nationality, disability, sexual orientation or age.
- Infringe any copyright, database right or trade mark of any other person. 4.4.6
- 4.4.7 Be likely to deceive any person.
- 4.4.8 Be made in breach of any legal duty owed to a third party, such as a contractual duty or a duty of confidence.
- 4.4.9 Promote any illegal activity.
- 4.4.10 Be threatening, abuse or invade another's privacy, or cause annoyance, inconvenience or needless anxiety.
- 4.4.11 Be likely to harass, upset, embarrass, alarm or annoy any other person.
- 4.4.12 Be used to impersonate any person, or to misrepresent your identity or affiliation with any person.
- 4.4.13 Give the impression that they emanate from us, if this is not the case.
- 4.4.14 Advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

5 **SUSPENSION AND TERMINATION**

- 5.1 We will determine, in our discretion, whether there has been a breach of this acceptable use policy through your use of our site. When a breach of this policy has occurred, or we reasonably suspect a breach of this policy has occurred, we may take such action as we deem appropriate. This may include, but is not limited to, those actions set out below in paragraph 5.2.
- 5.2 Failure to comply with this acceptable use policy constitutes a material breach of the terms of http://www.composide.com/wpuse content/uploads/2014/11/CompoSIDE_Terms_of_Use_November_2014.pdf upon which you are permitted to use our site, and may result in our taking all or any of the following actions:
 - 5.2.1 Immediate, temporary or permanent withdrawal of your right to use our site.
 - 5.2.2 Immediate, temporary or permanent removal of any posting or material uploaded by you to our site.



- 5.2.3 Issue of a warning to you.
- 5.2.4 Legal proceedings against you for reimbursement of all costs on an indemnity basis (including, but not limited to, reasonable administrative and legal costs) resulting from the breach.
- 5.2.5 Further legal action against you.
- 5.2.6 Disclosure of such information to law enforcement authorities as we reasonably feel is necessary.
- 5.3 We exclude liability for actions taken in response to breaches of this acceptable use policy. The responses described in this policy are not limited, and we may take any other action we reasonably deem appropriate.

You are expected to check this page from time to time to take notice of any changes we make, as they are legally binding on you.
