PRIVACY POLICY

CompoSIDE Limited ("We") are committed to protecting and respecting your privacy.

This privacy policy (together with our terms of use and any other documents referred to on it) explains how we use any personal information we collect about you when you use this website and make contact with us via telephone and/or e-mail.

INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following information about you:

Information you give us

You may give us information about you by:

- Filling in forms on our site http://www.composide.com/ ("our site");
- Corresponding with us by phone, e-mail or otherwise. This includes information you provide when
 you register to use our site, subscribe to our service, search for a product, participate in any
 discussion boards or other social media functions on our site, enter a competition, promotion or
 survey, use or access any subscription service, submit or provide any document, contribution or
 other information in the course of using our site or subscription services and when you report a
 problem with our site.

The information you give us may include your name, address, e-mail address and phone number, financial and credit card information, personal description and photograph.

Information we collect about you

With regard to each of your visits to our site we may automatically collect the following information:

- Information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;
- About your visit, including the full Uniform Resource Locators (URL) clickstream to, through and
 from our site (including date and time); products you viewed or searched for; page response
 times, download errors, length of visits to certain pages, page interaction information (such as
 scrolling, clicks, and mouse-overs), and methods used to browse away from the page and any
 phone number used to call our customer service number.

Information we receive from other sources

We may receive information about you if you use any of the other websites we operate or the other services we provide. In this case we will have informed you when we collected that data that it may be shared internally and combined with data collected on this site. We are also working closely with third parties (including, for example, business partners, subcontractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers, credit reference agencies) and may receive information about you from them.

HOW WE USE THE INFORMATION WE COLLECT ABOUT YOU

We use information held about you in the following ways:

Information you give us

We will use this information to:

• Carry out our obligations arising from any contracts entered into between you and us, and to provide you with the information and services that you request from us;

- To notify you about changes to our services;
- To ensure that content from our site is presented in the most effective manner for you and your computer.

Information we collect about you

We will use this information to:

- To manage and provide to you any of our services which you might subscribe for;
- To administer our site and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- To improve our site to ensure that content is presented in the most effective manner for you and your computer;
- To allow you to participate in interactive features of our site, if/when you choose to do so;
- As part of our efforts to keep our site safe and secure.

Information we receive from other sources

We may combine this information with information that you give and information that we collect about you. We may use this information and the combined information, for the purposes set out above (depending on the types of information we receive).

DISCLOSURE OF YOUR INFORMATION

We may share your personal information with any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries, as defined in section 1159 or the UK Companies Act 2006.

We may share your information with selected third parties including:

- Business partners, suppliers and sub-contractors for the performance of any contract we enter into with them, for you.
- Analytics and search engine providers that assist us in the improvement and optimisation of our site.
- Credit reference agencies for the purpose of assessing your credit score, where this is a condition of us entering into a contract with you.

We may disclose your personal information to third parties:

- In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets;
- If CompoSIDE Ltd or substantially all of its assets are acquired by a third party, in which case
 personal data held by it about its customers will be one of the transferred assets;
- if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use or terms and conditions for the supply of services and other agreements; or to protect the rights, property, or safety of CompoSIDE Limited, our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

We will not share your information for marketing purposes with companies outside of our own.

WHERE WE STORE YOUR PERSONAL DATA

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff maybe engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services.
